CAMPING POLICY

Each unit must register and pay camping fees in full in advance.

Rates include one recreation vehicle and one tent or 2 tents per site. Maximum of 3 tents per site is allowed. The third tent is allowed at an additional fee.

Before Memorial Day and after Labor Day all late arrivals (after office hours) must register at self registration station and pay all appropriate fees in advance of using camp site.

All reservations must be paid in full at time reservation is made.

During the period of Memorial Day through Labor Day, the self-registration is closed and campers must register during office hours.

Camping rates are based on 4 adults per site. Family members, 17 years old and under, stay free on same site after properly registering camping units.

Check out time is 3:00 PM. Check in time is anytime the site is available on check in day or 3:00 PM, whichever is earlier.

All campers wishing to stay longer must register by 10:00 AM on the original day of departure.

All vehicles must register and properly display car pass. Only two vehicles per site are included with fee. Additional fee is charged for more than two vehicles.

Parks Committee will establish camping fees.

We reserve the right to make adjustments in site assignment.

This is a family campground; therefore, NO MINORS (17 and under) are allowed to camp without a parent or legal guardian. Prior to Memorial Day Weekend all campers must be 21 years old to camp without a parent or legal guardian.

Quiet hours begin at 11:00 PM and end at 8:00 AM. We do expect that excessive noise will not come from a campsite at any time.

Campsites will be designated by the type of camping unit permitted. Tents are permitted on Tents Only Sites. Pop up campers, fold down campers, and tents are permitted on Pop Up Sites. Tents, pop up campers, fold down campers, truck campers, trailers, motor homes or any other hard sided recreational vehicle are permitted only on Recreational Vehicle Sites.

Recreational vehicles will park on pads provided at campsite. Vehicular traffic on the campsite grass will be kept to a minimum.

Camper forfeits unused portion of stay; if camper departs early unless there is a verifiable emergency.

All applicable county ordinances apply. (Reviewed October 2014)

Campsite Reservation Policy

Calumet County Parks Department will start taking reservations for camping six (6) months in advance to the date of the first night of the reservation. EXCEPTION: Dates will be established for the first acceptance date for Memorial Day Weekend, Father's Day Weekend, 4th of July, and Labor Day Weekend.

A separate reservation must be made for each campsite and each stay. A non-refundable reservation fee will be charged for each reservation.

A camping reservation will be for a minimum of two consecutive nights or a maximum of 21 consecutive nights in any calendar month.

Reservations for Memorial Day Weekend and Labor Day Weekend will be for a minimum of Friday, Saturday and Sunday nights. July 4th reservation minimum will vary according to the night this holiday falls upon.

Payment in full must be made at the time the reservation is made. (Reviewed July 2013)

CAMPSITE CANCELLATION AND CHANGES POLICY

Cancellations of reservations must be received by 3 pm two days prior to scheduled occupancy. Only the reservation fee will be charged.

Cancellations received after 3 pm two days prior to scheduled occupancy are subject to being charged one night's camping fee.

If no cancellation is received or there is no notification of late arrival, the reserved camp site will be made available at 10 am the day following the site was to initially be occupied. Cancellation fee applies.

The cancellation fees will be charged to the credit card. The cancellation fee included the reservation fee and one night's camping for each site.

There is no charge for changing reservations. Reservations cannot be carried forward to the next calendar camping year. (Reviewed October 2014)

Shelter Rental/Use Policy

Calumet County Park:

- No shelter reservations may be accepted six months prior to date of rental.
- The shelters may be rented between mid May through Labor Day weekend of each year.
- To make a reservation, payment in full plus reservation fee is required at the time of reservation.
- If there is a cancellation one week prior to the date of use of a shelter, the daily fee and tax will be refunded. The reservation fee is not refundable.
- If there is a cancellation less than seven days prior to the date of use of a shelter there will be no refund.
- Only scouts may use shelter overnight in conjunction with their camping.
- Renting party is responsible for any damage and cleans up of shelter and surrounding area. No security deposit is required.
- Shelter hours are 8:00 AM to 11:00 PM.
- Bands/DJ's are not permitted. Excessive noise is not permitted.

Ledge View Nature Center:

- No shelter reservations may be accepted six months prior to date of rental.
- The shelters may be rented between mid May through October 31st of each year.
- To make a reservation, payment in full plus reservation fee is required at the time of reservation.
- If there is a cancellation one week prior to the date of use of a shelter, the daily fee and tax will be refunded. The reservation fee is not refundable.
- If there is a cancellation less than seven days prior to the date of use of a shelter there will be no refund.
- Renting party is responsible for any damage and clean up of shelter and surrounding area. No security deposit is required.

- Shelter hours are from dawn to dusk.
- Bands/DJ's are not permitted. Excessive noise is not permitted.

Firewood Policy

In an effort to stop the spread of invasive pests and diseases that are harmful to Wisconsin's trees and the impact to Calumet County, only firewood from within Calumet County and is inside a 10 mile radius of Calumet County Park or from a certified firewood vendor is allowed.

Acceptable Firewood:

Firewood logs are allowed in Calumet County Parks only if the wood was harvested from inside a 10 mile radius of Calumet County Park in Calumet County.

People camping in Calumet County Park are allowed to bring scrap lumber for campsites as long as there are no nails or screws in them such as 2-by-4's and 2-by-6's used from a building project. Lumber is fully dried and debarked before it can be used in building, which means it cannot harbor pests and diseases of living trees like raw wood or logs can.

Be aware, if you transport firewood from Illinois, Indiana, Ohio, or Lower Michigan, you can be liable for federal fines up to \$1,000.00.

Minimally processed wood such as full or partial pallets, skids, or slabs will not be allowed in Calumet County Park.

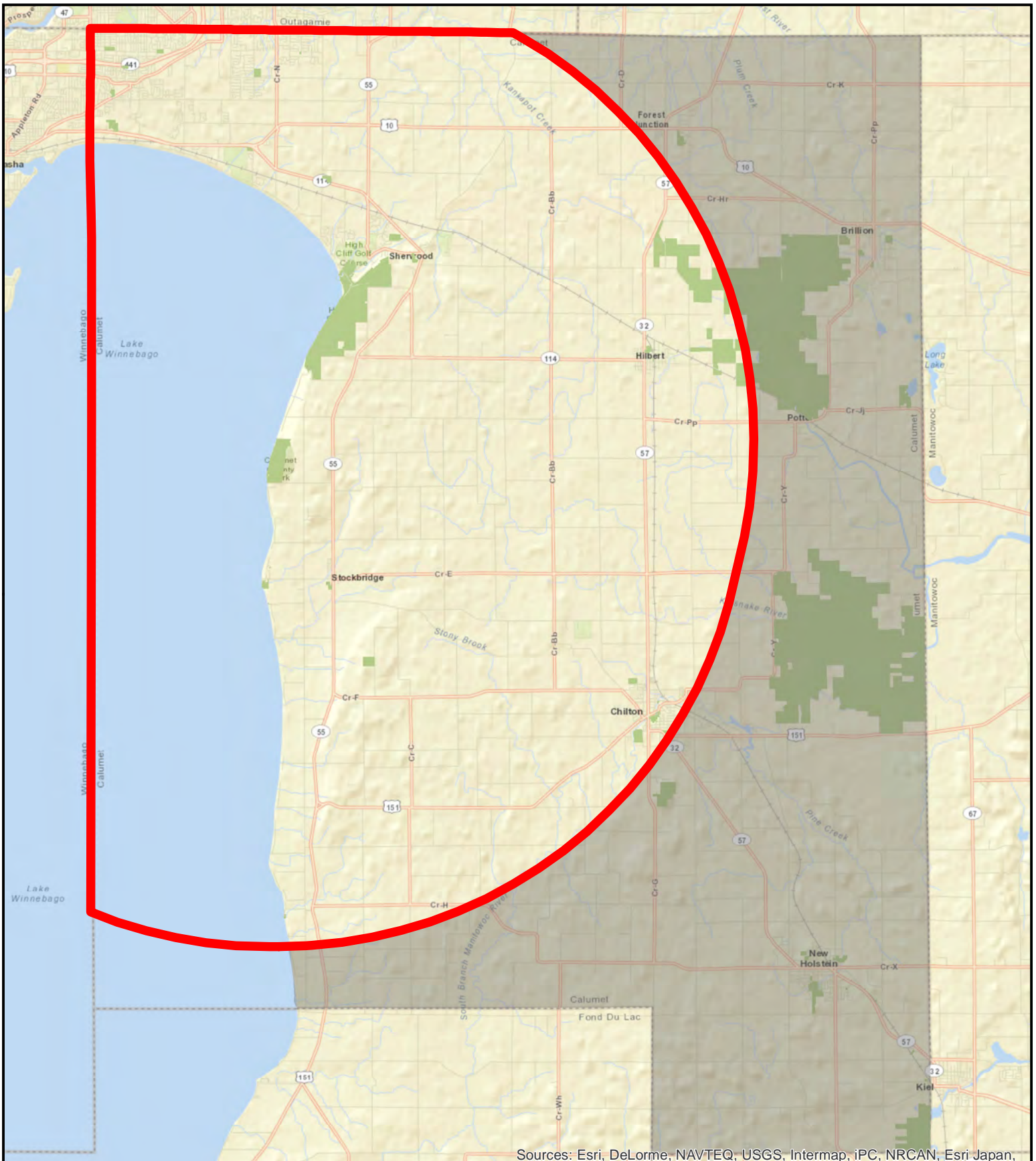
Please know that toxins are released when wood that is painted, treated with preservatives, or made up of a composite of wood and glue such as chipboard and plywood is burned and this is a serious health hazard. This type of wood will not be allowed to be burned on county property.

Illegal firewood will be confiscated immediately and double bagged in heavy plastic until it can be treated in a manner that will kill any forest pest hiding under the bark.

Firewood can be purchased in Calumet County Park.

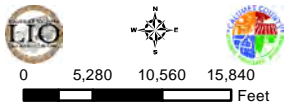
